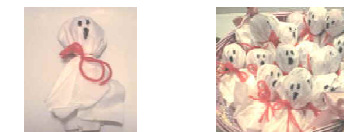

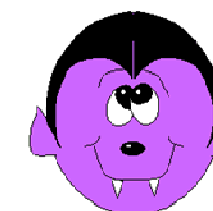

Brain Cupcakes



- 12 Cupcakes
- Butter cream Frosting
- Food Coloring

Spread a coat of light orange icing (stir drops of yellow and pink food coloring, and just a touch of green, into 2 cups of butter cream frosting until you have a hue you like) on a dozen cupcakes. **Employment Opportunities****Notice to Residents**

It is the policy of the Calhoun Housing Authority to provide employment opportunities to qualified residents of public housing. Calhoun Housing Authority requires all firms who are doing business with the authority to provide employment opportunities to low and very low-income persons, to the greatest extent feasible, and consistent with existing Federal, State, and local laws and regulations. Employment positions are posted on bulletin boards at the following location from 9:00 am to 5:00 pm weekdays.

Employment opportunities may also be available through contractors doing business with the housing authority. Such contracts include modernization of public housing units, grounds, maintenance, janitorial services; etc.... Residents should contact the Superintendent at each job site to inquire about employment opportunities with such firms.

- Satellite T.V. and High Speed Internet service requiring outside antennas **MUST** be purchased through Skywave at 706-629-0921. Skywave has made an agreement that they will install ONE aerial antennae per building that will service all units in a building. This prevents clutter on our roofs and protects the encased lead based paints that are on some buildings.

## Income Reporting Requirement for Calhoun Housing Authority Residents

Pursuant to the Computer Matching and Privacy Protection Act of 1988, HUD verifies the employment and income of individuals participating in HUD's rental housing assistance programs to correctly determine the amount of their rent and assistance programs. HUD will make the results of the computer match available to public housing agencies (PHAs) administering HUD rental assistance programs to enable them to verify employment and income and correctly determine the rent and assistance levels for individuals participating in those programs. This information also may be disclosed to the HUD Inspector General (HUD/IG), and the Attorney General in connection with the administration of the above named programs.

The Calhoun Housing Authority requires you to report any income changes in your household in writing within **10 days**. Failure to do so can cause you to be in violation of section 16 (b) of your lease which is...failure to provide timely and accurate statements of income, assets, expenses and family composition at Admission, Interim, Special or Annual Rent Recertifications, to attend scheduled reexamination interviews or to cooperate in the verification process if the Resident has chosen to pay rent based on a percentage of income. In addition to being in violation of your lease, you could owe back rent, have your lease terminated for committing fraud and/or could face prosecution by the Calhoun Housing Authority and/or from the HUD Inspector General .

Please do not jeopardize your housing. I do not want to see any of our families out in the cold this winter with no place to go. Plus the holidays will be here before we know it! If you anticipate having a problem paying your rent or the other charges – please contact this office immediately. We will work with you before it becomes a problem.*

*I believe the Authority is looking better with each small project we complete. I want to thank all of you that pitch in and help to keep our Authority looking as good as it does. There will be continued improvements with our Capital Funds and together we are going to keep this a great place to live and come home too! Thanks for all your hard work and support.*
